Cabcharge Gift Card Terms and Conditions

These conditions apply to use of the Cabcharge Gift Card (gift card), issued by Cabcharge Australia Limited ABN 99 001 958 390. Purchasing or using the gift card means that you accept these conditions. If you let another person use your gift card, you must tell them that they will be bound by these conditions. NSW law applies to this agreement. By entering into this agreement you unconditionally submit to the jurisdiction of the courts of NSW.

- Receipts can only be provided at the point of transaction on request.
- Card may be used to purchase services in taxis with "Cabcharge EFTPOS" terminal facilities in Australia, when the gift card has enough unused value to make the purchase.
- Gift cards cannot be redeemed for cash, reloaded, returned for a refund, have their balances consolidated to a new gift card, or be replaced and are not legal tender, account cards, credit or debit cards or securities.
- Keep your gift card secure - anyone holding the gift card can use its value to make purchases. If your gift card is lost or stolen we are not able to stop gift card value being used.
- A service fee of 10% plus GST will be charged at the point of sale.
- If you have a query or complaint about the gift card, please raise it through any of our contact channels. We are not liable for the availability, quality or fitness for purpose of any services purchased with the gift card. Any dispute about services purchased with the gift card must be resolved with the supplier or the suppliers tax network. Except for rights which cannot be excluded, any conditions or warranties implied or imposed by legislation or otherwise are excluded from these conditions of use. To the extent permitted by law, our liability is limited to replacing faulty gift cards.

- We may cancel any gift card, or the gift card scheme, for any reason at any time without notice. If so, we may either provide a refund or a replacement gift card of equivalent value unless we reasonably suspect fraud in relation to a gift card. The gift card remains our property.
- We can vary or replace these conditions from time to time (including to introduce new fees) by publishing a notice in a newspaper circulating throughout Australia at least 30 days before the change. The current version of these conditions is available through our contact channels.
- Gift Cards must be paid for in full prior to order being processed.
- IMPORTANT - EXPIRY DATE: THIS CARD WILL EXPIRE ONE YEAR AFTER THE DATE OF ISSUE - SOME MERCHANTS MAY CHOOSE NOT TO ACCEPT THE GIFT CARD.** After the gift card has expired, it is no longer valid. All transactions will be declined. Unused value will not be refunded and will become our property.
